General Meeting - July 20, 2016

The July 20th general meeting, held at Grayslake Middle School, was called to order at 6:30 PM. There were five board members in attendance.

At the first opportunity for public comments, no public comments were made.

Board/Superintendent Reports:

- Board Member **Tom Meskel** discussed the format for the Board Goals paperwork.
- Board Member **David Northern** discussed a meeting that Lake County leaders had recently regarding race relations in the suburbs. He stated that education is a big component. An area school district has implemented a program called "Adopt A Cop" where officers come into the schools to establish positive relationships with students. David discussed this with GMS Principal

Marcus Smith and learned that Mr. Smith is already in talks with the Grayslake Police Chief on establishing a similar program. Mr. Northern also mentioned that they are looking for ways to reach out to parents and community members as well. He thinks it is a great opportunity to share resources within the community and build better relationships.

- Board Vice President **Jim Weidman** brought up Public Act 99-515 regarding meeting minutes and wants to make sure the district is up to date. Superintendent Correll mentioned that she is aware of the Act.
- **Superintendent Correll** said the district has been busy hiring and interviewing, and the curriculum groups are meeting. Math worked today on grades 5-8 scope and sequence. Writing and Science groups meet next week. The ELA group met last week. Lots of work is going on regarding the PLC and recommendations from the PDT groups.

Unfinished Business:

Discussion of the Prairieview Sidewalk

Mr. Bobek stated that terms have changed on this project and the state will now pay for the sidewalk and the Village of Hainesville will be responsible for maintenance and upkeep of the sidewalk. If there are utilities that need to be moved that would be the responsibility of the District. Mr. Bobek said that there shouldn't be any cost to the District, but if there are costs involved the District will walk away from the deal.

Update on the FY 16-17 Budget

Mr. Bobek presented the preliminary budget assumptions of expenses and revenues. (*The presentation can be viewed online: <http://www.ustream.tv/recorded/89808556>*) Another budget presentation will take place at the August 10 Board of Education meeting as an action item. The second meeting in September will include the final budget presentation. Mr. Northern requested that the District schedule a couple community meetings so that the public can ask questions about the budget.

Update on Summer Projects

Summer Operations and Maintenance projects are under way - painting has been taking place around the district. RJB is a week ahead of schedule with washing/waxing the floors in the schools. Sealcoating will begin this upcoming week. Schools are looking good.

Discussion regarding goal setting next steps

Board Member Tom Meskel discussed the request for input on goals.

Professional Development for the administrators has already taken place by the District's attorney.

Discussion of the Negotiation Team

Negotiations with the teacher's union and PSRP union will begin this fall. The Unions are ready to begin, so as soon as the Board is ready contract negotiations can begin. Board President Steven Strack explained how the process worked during the last negotiation: The Board President and Vice President along with Superintendent Correll, and Asst. Superintendent Bobek and the District Attorney meet with Union representatives for each round of contract negotiations. The Union has a similar number of participants. The rest of the Board of Education wait in a caucus room and details of the negotiations are shared with them. Board Member David Northern suggested having a newer member of the board also be included in the direct

negotiations so that they have experience going forward. He agreed to join as a third board member in the direct negotiations. Board Vice President Jim Weidman stressed that they worked very hard to better the Board's relationship with the Unions and that they brought back a lot of positives from the experience. The Superintendent will contact the union presidents for scheduling.

Discussion of IASB Triple I Delegate

Board Member Rob Roop was the delegate at last year's meeting and Board Member David Northern was the alternate. Mr. Northern offered to be the delegate if Mr. Roop decides to step down.

Future Agenda Items:

- Budget - The Superintendent mentioned that she would like the Board to vote on the continuation of the technology pilot as presented by the Technology PDT team.
- Prairieview sidewalk
- 1.1million budget use
- Goals
- Second reading/action on policies
- Curriculum Committee

There were no comments at the second public comment session.

The Board of Education went into closed session at 7:34PM.
