- Board Member **David Northern** mentioned that the Diversity Committee information can now be found on the District website: <http://www.d46.org/diversity.asp>
- **Superintendent Correll** reported on the enrollment of the Right At School before/after-school program held in several of the district schools. Participation is going up in the program. The Superintendent also did a promotional video for Right At School. They have been our after school care provider for three years and participation, programs, and enrollment are all increasing.

Motion to approve the contract with Performance Services pending approval of legal counsel
Superintendent Correll explained updates to the contract approved by counsel and costs per building. Park Campus will be paid from developer donation, installation at the other buildings will be financed with State Bank of the Lakes. The goal is to not use any taxpayer dollars. Installation will begin first at Park Campus since that project has already been approved by the Village of Round Lake and funding is already in place. Meetings dates are being set up with the Villages of Hainesville and Grayslake.

Unfinished Business:

Update on the District Copiers

The Superintendent explained that the contract for half of the district's copier fleet will expire soon. Assistant Superintendent Mr. Chris Bobek met with four vendors last week. All four will come back with proposals. He will bring a recommendation to the board at the first meeting in November.

New Business:

Discussion of the Summer School Demographics

Superintendent Correll stated that many Summer Academy classes are even on gender demographics. The Minecraft activity camp had many more boys attend (17-6), but computer programming class was pretty equal. Cooking class and puzzle mania was attended by more girls than boys.

Discussion of the IASB Triple I Delegate

Board Member David Northern offered to be the delegate for the IASB Triple I Conference. The Board will discuss resolutions at the next meeting. A voting member for the dinner on Wednesday night was also needed - Mr. Northern volunteered for that as well, with Mr. Tom Meskel acting as alternate.

Discussion of the 10 Year Health Life Safety Survey at Park Campus

The district is required by the state to participate in a Health Life Safety Survey at the buildings every 10 years. The buildings are evaluated for life/safety devices that might be missing, like panic buttons, drinking fountains, ramps, etc. The building is also checked to make sure that the structural being of the school is in good shape - sidewalks, alarm systems, etc. The evaluation at Park Campus is currently underway.

Future Agenda Items:

There were no comments at the second public comment session.

The Board of Education meeting adjourned at 7:32 PM.
